**Contributors' Note**

1. The submission must be original, innovative and research based.
2. It has to be submitted exclusively to JATI Journal and to that effect, a 'Submission Declaration' is to be given (specimen attached).
3. The Editorial Board will promptly acknowledge the receipt of the submissions.
4. The submissions must not contain any obscene, defamatory nor discriminatory material against any specific cast, race, and religion of profession.
5. Each paper will be reviewed by the Editorial Board of the Institute. The Editorial Board will review submissions carefully on the criteria of scope, content, structure, research, analysis, creativity, accomplishment of the paper's purpose and inclusion of counter arguments in the submissions. Therefore, submission does not guarantee publication.
6. The Editorial Board reserves the right to make changes they consider necessary to eliminate ambiguity, printing and typing mistakes, to ensure accuracy and coherence as well as to improve the mode of expression and style and also have the authority to ask the author to make any such changes.
7. Plagiarism will immediately disqualify the submission for consideration and should be avoided for possible civil and criminal liability.
8. Submission for publication will be taken as acceptance of the terms in this note.

**Guideline for submission**

1. The submissions can be in the form of articles, case notes, book reviews and responses to scholarly legal works already published.
2. The submission must be in English. Except for naming any Law or quoting any sections from any Act or legislations, the use of *Bangla* should be avoided.
3. The submission must acknowledge the contribution of other research work, paper, journal; book or resource materials used and, therefore, comply the referencing and bibliographical instructions of **Oxford University Standard for Citation of Legal Authorities (OSCOLA)**.
4. Length of the submissions (exclusive of footnotes):
  - Articles: 5000 (five thousand) to 8000 (eight thousand) words  $\pm$  10%;
  - Case Notes: 2500 (two thousand five hundred) to 4000 (four thousand) words  $\pm$  10%;
  - Book Review: 2000 (two thousand) to 3000 (three thousand) words  $\pm$  10%;
  - Response: 3000 (three thousand) to 3500 (three thousand five hundred) words  $\pm$  10%.
5. The recommended font is Times New Roman. Font size in the text must be 12 whereas a larger font (14/16) can be used for headings.
6. All papers must contain a cover page that includes the title of the paper, name, designation, workplace, contact number and any other important piece of information that fully disclose author's personal and professional capacity.
7. The cover page must be followed by an 'Abstract' summarizing the major aspects of the entire paper in a single paragraph of no more than 300 words.
8. Manuscripts for publication must be submitted both in hard and soft form. Hard copies are to be sent to the Director (Research and Publication), Judicial Administration Training Institute, 15 College Road, Dhaka-1000.
