#### Evaluation Process:

1. Two written exams, each comprising 100 marks, will be held on two different dates in the first two months.
2. Two judgment writing exams, (one in civil and another in criminal) based on paper books, will be held in the last month of training.
3. Two exams will be held on Computer Literacy and E-Communication.
4. For breaches of discipline, the authority may deduct marks. For entering late to class (up to 10 minutes) on three occasions, 2 marks will be deducted. If a trainee does not attend a class or enters after 10 minutes of its commencement, 1 mark will be deducted.
5. The report on the field attachment will be evaluated with a total of 25 marks.
6. For breaches of discipline in Physical Training and Sports class, the authority may deduct marks. For entering late to class (up to 10 minutes) on three occasions, 2 marks will be deducted. If a trainee does not attend a class or enters after 10 minutes of its commencement, 1 mark will be deducted.

**Statute Review (Marks: 50)**

This module will help the participants to learn a good number of legislations through peer learning model. In this module each trainee judge will review one particular statute and present the same in the Statute Review Sessions before the Resource Persons. Participants are required to highlight important substantive and procedural provisions of the statute and examine their enforcement/implementation mechanism in the administrative and judicial process. They are also expected to express their reasoned opinion, suggestion and recommendations, if any.

Two participants will form a group. They will submit separate review report on one statute but will present their report orally through power point or any other tools of presentation on the day fixed for statute review sessions. ## **Statute Review Report: Submission Guideline**

1. Deadline for submitting review report is 22 May 2025 and participants are expected to present their report in an abridged form through power point or any other tools of presentation on the day fixed for the statute review sessions.
- 2 Total 20 minutes will be allocated to each group. 15 minutes for presenting their review report and 5 minutes for question answer session.
3. Participants will be assessed on their reasoning, analytical skill, critical thinking and overall presentation skills.
4. At the end of the presentation, other participants and the Panel of Resource Persons may ask relevant questions for clarification or to verify the depth of understanding of the participant. The Faculty Members may also participate in the discussion.
5. The Statute review report must not exceed 1200 words and must not be less than 1000 words. It has to be written either in English or in Bangla in accordance with the official language of the statute.
6. The Review Report must contain a cover page which includes the name of the reviewed Statute along with rule (if such rules are framed); course name, name of the module; name, roll, designation & working station of the participant and name of the Course Director.
7. Review Report needs to be typed and double-spaced on A4 size paper using one-inch margins on all sides.
8. Participants are recommended to use "Times New Roman" font; font size "12" for English write-up and SutonnyMJ with Bijoy Bayanno or Avro with Nikash font & font size "14" for Bangla write-up
9. Participants have to sign their names at the end of the Statute Review Report.
