

Notes for Contributors/Authors of JATI Journal

1. The manuscript of the article must be original, innovative and research based.
2. The article/writing must acknowledge the contribution of other research work, paper, journal, book or resource materials used and, therefore, comply with the reference and bibliographical instructions of **Oxford University Standard for Citation of Legal Authorities (OSCOLA)**.
3. Plagiarism in the submitted manuscript of the article is strictly prohibited. It will immediately disqualify the manuscript for consideration and should be avoided for possible civil and criminal liability.
4. The submitted manuscript will be checked by plagiarism software such as Turnitin. **Submission of AI generated e.g. Chat GPT** manuscript is prohibited and will lead to disqualification.
5. It has to be submitted exclusively to JATI Journal and to that effect, a "Submission Declaration" is to be given (specimen below).
6. The manuscript must not contain any obscene, defamatory or discriminatory material against any specific cast, race and religion, and profession.
7. The Editorial Board and Reviewers Panel will review submitted manuscripts on the criteria of scope, structure, research, analysis, creativity, accomplishment of the paper's purpose, and inclusion of counter arguments in the submissions. Therefore, submission of manuscript does not guarantee publication in the journal.
8. Submission of the manuscript of the article for publication will be taken as acceptance of the terms in this note.
9. The Editorial Board reserves the right to make changes they consider and also have the authority to ask the author to make any such changes.

Guideline for Submission to JATI Journal

1. Articles should be between **5000 (Five thousand) to 12,000 (Twelve thousand)** words (excluding footnotes). **An abstract having around 250-300 words** should be included.
2. All articles need to be typed and double-spaced on A4 sized paper (8.27 x 11.69) using one-inch margins on all four sides of each page and all pages should be numbered consecutively.
3. The recommended font is Times New Roman. Font size in the text and footnote must be 12 and 9 respectively whereas a larger font (14) can be used for headings.
4. Page numbers should be placed in the Upper Right within margin of the paper. The number should appear by itself with no punctuation and text.
5. All papers must contain a cover page that includes the title of the paper, name, designation, workplace, contact number and any other important piece of information that fully discloses author's personal and professional capacity.
6. Manuscripts for publication must be submitted both in hard and soft form. Hard copies are to be sent to the Director (Research and Publication), Judicial Administration Training Institute, 15 College Road, Dhaka- 1000, whereas soft copies of the same are to be sent at research.publication.jati@gmail.com
7. Each article will be reviewed by the reviewer. The author has to comply with the observations of the reviewer. Therefore, submission does not guarantee publication. Also note that the article/writing shall not be eligible for return, if not published.

Submission of Declaration
